

The board of Cessna Township Trustees opened in regular session on Monday September 12, 2016 at 7:30 pm with the fiscal officer and all trustees present. The minutes from the previous meeting were read along with the presentation of the monthly financial reports. Mr. Long moved to accept all reports as presented. Mr. Ault seconded with all voting aye.

John Steinman asked the board about the status of the cleanup on the Dean Tracy property.

Mr. Schwemer provided his zoning report with no zoning activity for the month.

After reviewing two quotes for web site design, Mr. Ault moved to proceed with Andy Emerine to develop a web site for Cessna Township. Mr. Long seconded and all voted aye. The fiscal officer will work with Mr. Emerine on the design and maintenance of the website.

The board discussed the next steps for the cleanup of the Dean Tracy property. Mr. Ault moved to contact the prosecutor's office and request a letter from Mr. Bailey stating that Roger Crates Excavating is ok to proceed with the cleanup of the property. Mr. Hull seconded the motion and all voted aye. Mr. Bailey will be contacted for the issuance of a letter.

It was noted that a portion of the excess grindings obtained from ODOT was donated to McDonald Township.

The board discussed the next round of Issue II funding and opted not to apply for any projects in this round (31).

The board also reviewed the North Central Ohio Solid Waste District plan with no objections noted.

The board discussed the drainage at the West end of TR 80. Concern was heard about the size of culvert under the road that currently is in place. The Burke Ziegler farm has recently undergone tile updates prompting the concern. The county engineer will be contacted for advice.
