The board of Cessna Township Trustees met in special session on Monday January 9, 2017 at 7:30 pm at the township hall with all trustees and fiscal officer present for the purpose of reorganizing for 2017. The fiscal officer opened the meeting and called for nominations for president of the board. Mr. Long moved to nominate Mr. Hull as president. Mr. Ault seconded with all voting aye.

President Hull then asked for nominations for vice-president. Mr. Long moved to nominate Mr. Ault for vice-president. Mr. Hull seconded with all voting aye.

Mr. Long motioned for the following special board representatives:  
Mr. Ault- Regional planning, Mr. Long- BKP ambulance board, Mr. Hull- Board of Health, and Mr. Long- fire prevention officer. Mr. Hull seconded the motion with all voting aye.

Mr. Long moved to maintain the Cessna Township Records Commission as the county auditor, president of the Cessna Township board of trustees and the fiscal officer. Mr. Ault seconded with all voting aye.

Mr. Ault moved to maintain the audit/budget committee as the trustees and fiscal officer. Mr. Long seconded with all voting aye.

Mr. Long moved to hold monthly meetings at the township hall on the second Monday of each month starting at 7:30 p.m. Mr. Ault seconded with all voting aye.

Mr. Ault moved to establish the Kenton Times as the official newspaper for all legal notices. Mr. Hull seconded with all voting aye.

Mr. Hull moved to reimburse mileage at a rate of .50 per mile. Mr. Ault seconded with all voting aye.
