The minutes from the previous meeting were read along with the presentation of the monthly financial reports. Mr. Hull moved to accept all reports as presented. Mr. Long seconded the motion with all voting aye.

Keith Hughes was present to ask about the letter he received regarding violations of the junk vehicle ordinance on his property. The zoning officer provided direction to Mr. Hughes on what was needed to get his property back within compliance. Mr. Hughes indicated that he would start the needed cleanup and the zoning officer noted that he would be monitoring the progress.
