The board of Cessna Township Trustees opened in regular session on Monday, July 22nd, 2019 at 7:00 P.M. at the township hall with the fiscal officer and all trustees present. The minutes from the previous meeting were read along with the presentation of the monthly financial reports. Mr. Vermillion moved to accept all reports as presented. Mr. Eibling seconded the motion with all voting aye.

Mr. Schwemer's zoning report was read. The building that is non-compliant on the Sally Rupe property was discussed by the board and it was noted that the zoning officer is directed to contact the county prosecutor if the building is not removed by the 08/01/2019 deadline previously set by the board.

It was also noted that the triangle property has generated some concerns from residents that are concerned the structures on the property were not secured. The board agreed that they had no legal right to enter on to the property to address such concerns. The zoning officer will be asked to research what can be done to secure the buildings. The fiscal officer noted that the charges that the township incurred for cleaning and mowing of the property last year have still not been reimbursed because the taxes remain unpaid by the owner.
