The board of Cessna Township Trustees opened in regular session on Monday, April 13, 2020 at 7:00 P.M. at the township hall with the fiscal officer and all trustees present. The minutes from the previous meeting were read along with the presentation of the monthly financial reports. Mr. Hull moved to accept all reports as presented. Mr. Eibling seconded the motion with all voting aye.

Daryl Flowers, Hardin County Township Association was present to discuss an ongoing situation between the City of Kenton and BKP.

Larry Ludwig was also on hand to discuss zoning variance matters.

Mr. Schwemer gave his monthly zoning report.

Mr. Eibling moved and Mr. Vermillion seconded the following summer road projects with the Hardin County Engineer:
