The board of Cessna Township Trustees opened in regular session on Monday, August 12, 2024 at 7:00 P.M. at the township hall with the fiscal officer and trustees Hull and Eibling present. The minutes from the previous meeting were read along with the presentation of the monthly financial reports. Mr. Eibling moved to accept all reports as presented. Mr. Hull seconded the motion with all voting aye.

Mark Schwemer gave his monthly zoning report.

The board received another quote for adding a concrete pad at the entrance to the northeast door of the new equipment building from Top Choice Asphalt and Concrete. Rish Concrete is currently the only other quote received. More quotes will continue to be sought.

The board reviewed the proposed Local Government and Local Government Revenue Assistance Fund distribution proposal that was drafted by the Hardin County Budget Commission as discussed at the last Hardin County Township Association meeting.

Resolution # 2024-03

Whereas: Mr. Eibling resolves to adopt the formula as proposed by the Hardin County Budget Commission to distribute Local Government and Local Government Revenue Assistance funds to Hardin County local government recipients at the same percentage levels as previously agreed upon.

Wetherefore: Agree to distribute the funds as follows:

- Hardin County 50.00%
- City of Kenton 14.00%
- Villages 16.00%
- Townships 20.00%

Within the percentage of total funds allocated to the townships and villages, the funds shall be dispersed according to the following formula:

- 50% Road Miles
- 25% Population
- 25% Valuation
