

March 13, 2023

The board of Cessna Township Trustees opened in regular session on Monday, March 13, 2023 at 7:00 P.M. at the township hall with the fiscal officer and trustees Vermillion and Hull present. The minutes from the previous meeting were read along with the presentation of the monthly financial reports. Mr. Vermillion moved to accept all reports as presented. Mr. Hull seconded the motion with all voting aye.

Mark Schwemer presented his monthly zoning update.

It was noted that the sale of the John Deere 5525 tractor and loader was completed at the annual Hardin County Consignment sale on March 11, 2023. The tractor and loader was sold for \$30,000 less a sale commission fee of \$1,500. The tractor and loader will be removed from the township’s insurance policy right away.

Mr. Hull motioned to contact Joey Fall in regards to providing two roll off dumpsters for the annual township cleanup that is scheduled for Saturday April 1, 2023. Mr. Vermillion seconded the motion with all voting aye. The annual event will be advertised in The Kenton Times.

The board reviewed a quote from Quality Paving for the resealing and restriping of the township hall parking lot. The board will seek more quotes before proceeding.

The Fiscal Officer updated the board on his continuing interaction with PNC Bank to change the billing cycle dates for the township’s credit card. The bank was originally requesting that a resolution from the board authorizing the Fiscal Officer to serve as the account administrator for the bank card. They have now indicated that the account was no longer able to be updated due to it being a type of card that they no longer offer. The only option left with PNC was to close out the old credit card and apply for a new PNC card. The Fiscal Officer suggested that since PNC Bank no longer has a local branch that the board contact our local bank, First Citizens National Bank, to apply for a township credit card with them. Mr. Hull motioned to approve authorizing the township Fiscal Officer to close out the PNC Bank credit card and apply for a new township credit card with The First Citizens National Bank. Mr.Vermillion seconded with all voting aye.
