The board of Cessna Township Trustees opened in regular session on Monday, May 13, 2024 at 7:00 P.M. at the township hall with the fiscal officer and trustees Vermillion and Hull present. The minutes from the previous meeting were read along with the presentation of the monthly financial reports. Mr. Hull moved to accept all reports as presented. Mr. Vermillion seconded the motion with all voting aye.

Mark Schwemer presented his monthly zoning update.

The board reviewed a quote from King Plumbing for the replacement of the broken water heater and installation of iron filters in the township hall. The estimate also includes the replacement of the leaking bathroom faucet and water lines for a total cost of \$1,280.43. Mr. Vermillion moved to proceed with the repairs as estimated. Mr. Hull seconded with both voting aye.

A single quote from Adam Haudenscheid’s Tree Service in the amount of \$2,700 was reviewed by the board for the removal of seven trees on Township Road 100 between CR 135 and Township Road 125. Mr. Hull moved to proceed with the work as quoted. Mr. Vermillion seconded with both voting aye.
